To stay ahead, management always strives to achieve the following:

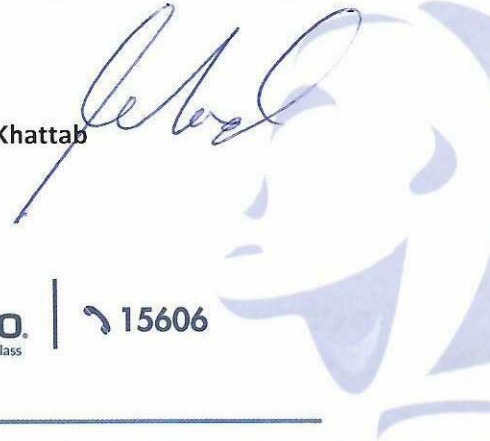
